You acknowledge (a) that you have read and understood this Privacy Policy; and (b) this Privacy Policy shall have the same force and effect as a signed agreement.

We reserve the right to modify or discontinue the Reeher Mobile Application (or any portion of the Reeher Mobile Application), temporarily or permanently, with or without notice to you, and are not obligated to support or update the Reeher Mobile Application.

You agree that Reeher shall not be liable to you or any third party in the event that we exercise our right to modify or discontinue the Reeher Mobile Application (or any portion of the Reeher Mobile Application). Unless explicitly stated otherwise, any new features that augment or enhance the current Reeher Mobile Application shall be subject to this Privacy Policy.

This Privacy Policy was last revised on August 21, 2014. We may change or add to this Privacy Policy, so we encourage you to review it periodically. If we materially change this Privacy Policy, we'll let you know by showing it to you again when you open the Reeher Mobile Application.

#### **CUSTOMER DATA/USER DATA**

Reeher customers may electronically submit data or information about fundraising prospects and donors to the Services for hosting and processing purposes ("Customer Data") Reeher will not review, share, distribute, or reference any such Customer Data except as provided in the Master Subscription Agreement, or as may be required by law. Reeher may access Customer Data in accordance with the Master Subscription Agreement. Personal information about or generated by users of Reeher's website and Services ("User Data") is not Customer Data.

#### 1. Information We Collect

We collect the following types of User Data in the manner described below.

- · You may voluntarily provide us with information;
- Your name;
- · Your email address;
- Your password that you've created;
- You may voluntarily provide us with access to your phone's geographic location information, like your current zip code, when you are
  using the Reeher Mobile Application to improve your user experience; and
- Any other information that you provide in registering for or using the Reeher Mobile Application.

#### 2. We automatically collect other information about you and/or about your device, including:

- Your IP address:
- The Reeher Mobile Application features that you use and the time of your use; and

### 3. How We Use Your Information

We use the User Data that we collect for the following purposes, including:

- The purposes for which you provided it;
- To process and respond to your inquiries and comments;
- · To send you information about your relationship or transactions with us;
- To develop new products and services;
- To personalize and enhance your experience using the Reeher Mobile Application;
- To contact you with information, including promotional information and recommendations, that we believe will be of interest to you;
- Advertisements;
- To generate and review reports and data about our user base and service usage patterns;
- To compile aggregate data for internal and external business purposes;
- To perform other business activities as needed, or as described elsewhere in this Privacy Policy;
- To prevent fraud and abuse of the Reeher Mobile Application and to otherwise protect users and visitors and our business;
- To assist law enforcement and respond to subpoenas;
- To administer, operate and improve the Reeher Mobile Application and its Services and for internal business purposes; and

As otherwise stated in this Privacy Policy.

Other uses of the User Data or Customer Data may be permitted under the Reeher Services Agreement or Reeher Services EULA.

#### HOW USER DATA IS DISCLOSED

User Data may be disclosed to third parties in accordance with our website Privacy Policy. Please note that a user may choose not to share certain information as described in Your Choices Regarding Your Information below.

Third Party Service Providers and Business Partners. We may use third party service providers and business partners to perform functions in connection with the Reeher Mobile Application. Examples include functions related to analyzing and improving the Reeher Mobile Application usefulness, advertising, marketing, storing data, providing users with products and services, administrative functions such as back up and security, and as otherwise described in this Privacy Policy. We may share information about you that they need to perform their functions. We may deliver advertisements to you. We may work with third-party advertising companies that help deliver these advertisements to you. Reeher also utilizes a third party service to collect information about Reeher Mobile Application crashes. This information is used to improve the performance of the Reeher Mobile Application. The information collected includes device state information at the time a crash occurred, unique device identifiers, and information relating to the physical location of a device at the time a crash occurred.

Third Parties for Their Direct Marketing and Other Promotional Purposes. We may share your User Data with third parties, including our business partners, for their direct marketing and other promotional purposes.

**Customer**. We disclose User Data about your use of the Reeher Mobile Application to the Reeher customer with which you are employed, affiliated or associated ("Customer").

**Business Changes**. If we become involved in a merger, acquisition, sale of assets, bankruptcy, reorganization, dissolution, or other transaction or if the ownership of all or substantially all of our business otherwise changes, we may transfer your User Data to a third party or parties in connection therewith.

**Investigations and Law**. We reserve the right to investigate fraud and abuse on the Reeher Mobile Application and its Services. We may disclose User Data to third parties if we have a good faith belief that such disclosure is reasonably necessary to:

- Take action regarding suspected illegal activities;
- Enforce or apply this Privacy Policy or other agreements with us;
- · Comply with the law or guidance and cooperate with government or law enforcement officials or private parties;
- Protect our rights, reputation, safety, and property, or that of users or others;
- Respond to claims and legal process (for example, subpoenas); and/or
- Protect against legal liability.

Aggregated Information. We may share aggregated User Data with affiliated or unaffiliated third parties

**Security**. While we take reasonable measures to protect the User Data you submit via the Reeher Mobile Application against loss, theft and unauthorized use, disclosure, or modification, we cannot guarantee its absolute security. No Internet or app transmission is ever fully secure or free of errors. You should use caution whenever submitting User Data through an application and take special care in deciding with which information you provide us.

**Data Retention Policy, Managing Your Information**. We will retain your User Data for as long as you use the Reeher Mobile Application and for a reasonable time thereafter. Please note that some or all of the User Data we have collected may be required in order for the Reeher Mobile Application to function properly.

Links to Other Websites or Applications. This Privacy Policy applies only to the Reeher Mobile Application. The Reeher Mobile Application may contain links to other websites or apps or may forward users to other websites or apps that we may not own or operate. The links from the Reeher Mobile Application do not imply that we endorse or have reviewed these websites or apps. The policies and procedures we describe here do not apply to these websites or apps. We neither can control nor are responsible for the privacy practices or content of these websites or apps. We suggest contacting these websites or app providers directly for information on their privacy policies.

#### YOUR CHOICES REGARDING YOUR INFORMATION

You have choices regarding the use of your User Data by the Reeher Mobile Application. To change your information, including keeping your information accurate, please contact the Customer's administrator who has access to modify your information.
