THIS PRIVACY POLICY PERTAINS TO YOUR ACCESSING AND USING REEHER SERVICES VIA THE BLACKBAUD VOLUNTEER NETWORK FUNDRAISING APPLICATION WHICH YOU DOWNLOADED THROUGH APPLE'S ITUNES OR APPLE'S APP STORE ("BLACKBAUD VOLUNTEER NETWORK FUNDRAISING APPLICATION").

This policy describes the information collected during registration for and directly through the Blackbaud Volunteer Network Fundraising Application. The Blackbaud Volunteer Network Fundraising Application connects you to the Blackbaud Volunteer Network Fundraising website where you can use the Services (as defined in the Reeher Privacy Policy).

You acknowledge (a) that you have read and understood this Privacy Policy; and (b) this Privacy Policy shall have the same force and effect as a signed agreement.

We reserve the right to modify or discontinue the Blackbaud Volunteer Network Fundraising Application (or any portion of the Blackbaud Volunteer Network Fundraising Application), temporarily or permanently, with or without notice to you, and are not obligated to support or update the Blackbaud Volunteer Network Fundraising Application.

You agree that Reeher shall not be liable to you or any third party in the event that we exercise our right to modify or discontinue the Blackbaud Volunteer Network Fundraising Application (or any portion of the Blackbaud Volunteer Network Fundraising Application). Unless explicitly stated otherwise, any new features that augment or enhance the current Blackbaud Volunteer Network Fundraising Application shall be subject to this Privacy Policy.

This Privacy Policy was last revised on January 16, 2016. We may change or add to this Privacy Policy, so we encourage you to review it periodically. If we materially change this Privacy Policy, we'll let you know by showing it to you again when you open the Blackbaud Volunteer Network Fundraising Application.

### **Customer Data/User Data**

Reeher customers may electronically submit data or information about fundraising prospects and donors to the Services for hosting and processing purposes ("Customer Data"). Reeher will not review, share, distribute, or reference any such Customer Data except as provided in the Master Subscription Agreement, Order Form, or as may be required by law. Reeher may access Customer Data in accordance with the Master Subscription Agreement or Order Form. Personal information about or generated by users of Reeher's website, mobile applications, and Services ("User Data") is not Customer Data.

#### I. Information We Collect

We collect the following types of User Data in the manner described below.

- You may voluntarily provide us with information;
- Your name;
- · Your email address;
- Your password that you've created;
- Your activities that are initiated from the Blackbaud Volunteer Network Fundraising application; and
- · Any other information that you provide in registering for or using the Blackbaud Volunteer Network Fundraising Application.

#### A. We automatically collect other information about you and/or about your device, including:

- · Your IP address;
- Your User ID;
- The Blackbaud Volunteer Network Fundraising Application features that you use and the time of your use; and
- Other information about you collected through Reeher's website and as described in Reeher's then-current website privacy policy at https://performancemanagement.blackbaud.com/ihelp/display/Help/VOLUNTEER+NETWORK+FUNDRAISING+WEBSITE+PRIVACY+POLICY, to which you have already agreed.

#### II. How We Use Your Information

We use the User Data that we collect for the following purposes, including:

• The purposes for which you provided it;

- To process and respond to your inquiries and comments;
- To send you information about your relationship or transactions with us;
- To develop new products and services;
- To personalize and enhance your experience using the Blackbaud Volunteer Network Fundraising Application;
- Advertisements:
- To generate and review reports and data about our user base and service usage patterns;
- To compile aggregate data for internal and external business purposes;
- To perform other business activities as needed, or as described elsewhere in this Privacy Policy;
- To prevent fraud and abuse of the Blackbaud Volunteer Network Fundraising Mobile Application and to otherwise protect users and visitors and our business;
- To assist law enforcement and respond to subpoenas;
- To administer, operate and improve the Blackbaud Volunteer Network Fundraising Application and the Reeher Services and for internal business purposes; and
- As otherwise stated in this Privacy Policy.

Other uses of the User Data or Customer Data may be permitted under the Reeher Master Subscription Agreement or Blackbaud Volunteer Network Fundraising EULA.

### III. How User Data is Disclosed

User Data may be disclosed to third parties in accordance with our website Privacy Policy. Please note that a user may choose not to share certain information as described in Your Choices Regarding Your Information below.

A. Third Party Service Providers and Business Partners. We may use third party service providers and business partners to perform functions in connection with the Blackbaud Volunteer Network Fundraising Application. Examples include functions related to analyzing and improving the Blackbaud Volunteer Network Fundraising Application usefulness, advertising, marketing, storing data, providing users with products and services, administrative functions such as back up and security, and as otherwise described in this Privacy Policy. We may share information about you that they need to perform their functions. We may deliver advertisements to you. We may work with third-party advertising companies that help deliver these advertisements to you. We use Google Analytics and other third-party analytics providers to better understand who is using the Blackbaud Volunteer Network Fundraising Application and how people are using it. These analytics providers use cookies, pixel tags and other technologies to collect and store information such as pages visited, places where users click, time spent on each page, IP address, type of operating system used, location-based data, device ID, search history, and phone number. We use this information to improve the Blackbaud Volunteer Network Fundraising Application and as otherwise described in this Privacy Policy. **Use of Intercom Services:** We also provide a limited amount of your information (such as your email address and sign-up date) to Intercom, Inc. ("Intercom") and utilize Intercom to collect data for analytics purposes when you visit our website or use the Blackbaud Volunteer Network Fundraising Application. Intercom analyzes your use of our website and/or the Blackbaud Volunteer Network Fundraising Application and tracks our relationship so that we can improve our service to you. We may also use Intercom as a medium for communications, either through email, or through messages within our product(s). As part of our service agreements, Intercom collects publicly available contact and social information related to you, such as your email address, gender, company, job title, photos, website URLs, social network handles and physical addresses, to enhance your user experience.

Reeher also utilizes a third party service to collect information about Blackbaud Volunteer Network Fundraising Application crashes. This information is used to improve the performance of the Blackbaud Volunteer Network Fundraising Application. The information collected includes device state information at the time a crash occurred, unique device identifiers, and information relating to the physical location of a device at the time a crash occurred.

- **B.** <u>Third Parties for Their Direct Marketing and Other Promotional Purposes</u>. We may share your User Data with third parties, including our business partners, for their direct marketing and other promotional purposes.
- C. <u>Customer</u>. We disclose User Data about your use of the Blackbaud Volunteer Network Fundraising Application to the Reeher Customer with which you are employed, affiliated or associated.
- **D.** <u>Business Changes</u>. If we become involved in a merger, acquisition, sale of assets, bankruptcy, reorganization, dissolution, or other transaction or if the ownership of all or substantially all of our business otherwise changes, we may transfer your User Data to a third party or parties in connection therewith.
- E. <u>Investigations and Law</u>. We reserve the right to investigate fraud and abuse on the Blackbaud Volunteer Network Fundraising Application and the Reeher Services. We may disclose User Data to third parties if we have a good faith belief that such disclosure is reasonably necessary to:
  - Take action regarding suspected illegal activities;
  - Enforce or apply this Privacy Policy or other agreements with us,
  - · Comply with the law or guidance and cooperate with government or law enforcement officials or private parties;
  - Protect our rights, reputation, safety, and property, or that of users or others;
  - Respond to claims and legal process (for example, subpoenas); and/or
  - Protect against legal liability.
- F. Aggregated Information. We may share aggregated User Data with affiliated or unaffiliated third parties.

# **IV. Security**

While we take reasonable measures to protect the User Data you submit via the Blackbaud Volunteer Network Fundraising Application against loss, theft and unauthorized use, disclosure, or modification, we cannot guarantee its absolute security. No Internet or app transmission is ever fully secure or error free. You should use caution whenever submitting User Data through an application and take special care in deciding with which information you provide us.

# V. Data Retention Policy, Managing Your Information

We will retain your User Data for as long as you use the Blackbaud Volunteer Network Fundraising Application and for a reasonable time thereafter. Please note that some or all of the User Data we have collected may be required in order for the Blackbaud Volunteer Network Fundraising Application to function properly.

# VI. Links to Other Websites or Applications

This Privacy Policy applies only to the Blackbaud Volunteer Network Fundraising Application. The Blackbaud Volunteer Network Fundraising Application may contain links to other websites or apps or may forward users to other websites or apps that we may not own or operate. The links from the Blackbaud Volunteer Network Fundraising Application do not imply that we endorse or have reviewed these websites or apps. The policies and procedures we describe here do not apply to these websites or apps. We neither can control nor are responsible for the privacy practices or content of these websites or apps. We suggest contacting these websites or app providers directly for information on their privacy policies.

# VII. Your Choices Regarding Your Information

You have choices regarding the use of your User Data by the Blackbaud Volunteer Network Fundraising Application. To change your information, including keeping your information accurate, please contact the Customer's administrator who has access to modify your information.

If you no longer want this application to collect and use information about you:

 Uninstall the Blackbaud Volunteer Network Fundraising Application - You can stop all collection of information by the Blackbaud Volunteer Network Fundraising Application by uninstalling the mobile application. You may use the standard uninstall processes available as part of your mobile device or via the mobile application marketplace or network.

# VIII. Information Collected From Other Websites and Mobile Applications, and Do Not Track Policy

Through cookies we place on your browser or device, Reeher and our marketing partners may collect information about your online activity after you leave the Blackbaud Volunteer Network Fundraising Application. Just like any other usage information we collect, this information allows us to improve the Blackbaud Volunteer Network Fundraising Application and customize your online experience, and otherwise as described in this privacy policy. Your browser may offer You a "Do Not Track" option, which allows you to signal to operators of websites and mobile applications and services (including behavioral advertising services) that you do not wish such operators to track certain of your online activities over time and/or across different websites and mobile applications and services. The Blackbaud Volunteer Network Fundraising Application does not support Do Not Track requests at this time, which means that we collect information about your online activity both while you are using the Blackbaud Volunteer Network Fundraising Application.

We do not knowingly collect personal information from an individual under age 13. If you are under the age of 13, please do not submit any personal information through the Blackbaud Volunteer Network Fundraising Application. # XI. Your California Privacy Rights
